


# Dallas, Rockwall, Kaufman, Van Zandt 2024

February 24<sup>th</sup>, 2024

Today, we'll explore 4 counties near Dallas, TX. We'll start at the Old Red Courthouse in downtown Dallas. This is the 2007 restored courthouse from 1892 that replaced the wood structures of the old county courthouses/seat. From there, we'll travel through Deep Ellum for those that have never been there and then travel on I-30 East to Rockwall. In Rockwall, we'll first visit the old courthouse erected in 1941 and then head down to the new one, built in 2011.

Here in Rockwall, we'll take a pit stop and then travel South to Kaufman County, passing by Buc-ees. Once we reach downtown Kaufman, we'll realize the old Courthouse was a replacement of the previous Courthouse that was modeled after the one in Weatherford (did you get to attend the January 1<sup>st</sup> trip?). At this time, the Kaufman County Courts have moved to a new Kaufman Justice Center, which is where we'll head next.

After Kaufman, we'll finally find some nice twisty roads and head toward Canton, the seat of Van Zandt County. Here you'll find a court house that replaced the original through the work of the Works Progress Administration of the Depression-era. To the East, we'll walk over to Val's Italian and have lunch.



Starting Point (9:00a): On Main St facing East, Old Red Courthouse (600 Commerce St, Dallas, TX 75202). If needed, we can potentially park on the blue section of the side next to the court house (ie, there are limited meter spots but we think we can park along the road to get our pictures in)

Courthouses to Stop at (hoping for a 10 minute or so stop to get a picture and look around)

- Rockwall County Historic Court House (101 E Rusk St, Rockwall, TX 75087)
- Rockwall County current court house (1111 E Yellow Jacket Ln #100, Rockwall, TX 75087)
- Kaufman County Court House (100 W Mulberry St, Kaufman, TX 75142) (might have to circle the building to park on the North side)
- Kaufman County Justice Center (1904 US-175, Kaufman, TX 75142)
- Van Zandt County Courthouse (121 E Dallas St # 302, Canton, TX 75103) – we'll try to park along the north side on TX-64.

End Point: (~12:30p): Val's Italian Restaurant & Pizza (116 S Capitol St, Canton, TX 75103) – East of the Courthouse; <http://valsitalianrestaurant.com/> ; +1-903-567-3388

Total Trip Length: 91 miles; 3 hours, 30 minutes (with stops included)


